

## REGARDING AURORA AIRPORT EXTENSION

IT'S SIMPLE. WHO WINS? WHO LOSES?

PROponents ARE THE LARGE LAND HOLDERS WITH AIRCRAFT TAXI ACCESS AND WISH TO BUILD MORE HANGERS, AND SIMULTANEOUSLY RAISE RENTS ON CURRENT HANGERS.

WHO LOSES? THOSE OF US WHO LIVE IN WILSONVILLE, AURORA AND ENVIRONS DUE TO NOISE AND AIR POLLUTION.

THE CITIES OF WILSONVILLE AND AURORA WILL HAVE SOME SIGNIFICANT DEVELOPMENT AND SUPPORT EXPENSE. CONSIDER THE PROBLEMS OF A VERY HIGH WATER TABLE AS IT INTERRELATES WITH SEWAGE PROBLEMS. THE SURFACE TRANSPORTATION PROBLEMS ARE OBVIOUS

ALSO WHO PROVIDES FIRE DEPT. PROTECTION FOR A MAJOR AIRPORT.
