ORDINANCE NO. 26
O PREVENT THE PRACTIC

AN ORDINANCE TO PREVENT THE PRACTICE OF PERSONS GOING IN AND UPON PRIVATE PROPERTY OR CALLING AT RESIDENTS IN THE CITY OF WILSONVILLE, OREGON, BY SOLICITORS, PEDDLERS, HAWKERS, ITINERANT MERCHANTS, TRANSIENT VENDORS OF MERCHANDISE AND TRANSIENT PHOTOGRAPH SOLICOTORS NOT HAVING BEEN REQUESTED OR INVITED SO TO DO BY THE OWNER OR OWNERS, OCCUPANT OR OCCUPANTS OF SAID PRIVATE RESIDENTS; DECLARING SUCH PRACTICE TO BE A NUISANCE; PROVIDING THE PENALTY FOR THE VIOLATION THEREOF; AND DECLARING AN EMERGENCY.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: A practice of persons going in and upon private property or calling at residences in the City of Wilsonville or by solicitors, peddlers, hawkers, itinerant merchants, transient vendors of merchandise and transient photograph solicitors not having been requested or invited so to do by the owner or owners, occupant or occupants of said private residences for the purpose of soliciting orders for the sale of goods, wares and merchandise and/or for the purpose of disposing of and/or peddling or hawking the same, or soliciting orders for photographs, is hereby prohibited and declared to be a nuisance, and punishable as such nuisance as a misdemeanor.

Section 2: The Police Department and police officers of the City of Wilsonville are hereby required and directed to suppress the same and to abate any such nuisance as is described in the first Section of this Ordinance.

Section 3: Any person convicted of perpetrating a nuisance as described and prohibited in the first Section of this Ordinance, on conviction thereof, shall be punished by a fine of not to exceed Two Hundred Dollars (\$200.00) or by imprisonment in the County Jail not exceeding one hundred (100) days, or by both such fine and imprisonment.

Section 4: All Ordinances, or parts of Ordinances, in conflict with this Ordinance are hereby repealed.

Section 5: Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of

the City of Wilsonville and its residents in that said residents and inhabitants of this City of Wilsonville are continuously bothered with agents and peddlers of merchandise; and to eliminate such nuisance, it is deemed necessary that an emergency be and the same is hereby declared to exist, and this Ordinance shall be in force and effect from and after its final passage by the City Council and approval by the Mayor.

Passed on first reading at a regular meeting of the Wilson-ville City Council this 26th day of July, 1971; ordered posted in three (3) public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter, and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof to be held on the \_\_\_\_\_ day of August, 1971, at the hour of 7:30 o'clock p.m., Oregon Daylight Saving Time, at the Council's regular meeting place in the Wilsonville IOOF Hall.
