ORDINANCE NO. 37

AN ORDINANCE AMENDING THE CITY'S BUSINESS LICENSE ORDINANCE NO. 10; INCREASING LICENSE FEES; AND PROVIDING AN EFFECTIVE DATE.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: Sections 1 and 3 of Ordinance No. 10 entitled "AN ORDINANCE PROVIDING FOR THE LICENSING OF BUSINESSES FOR THE PURPOSE OF CITY REVENUE; ESTABLISHING LICENSE FEES; AND PROVIDING PENALTIES FOR VIOLATIONS" and enacted October 20, 1969 are hereby amended to provide as follows:

"Section 1: All persons as defined in this Ordinance who are engaged in business as defined by this Ordinance in the City of Wilsonville are required to apply annually for a business license and pay the license fee as prescribed by this Ordinance.

A. As used in this Ordinance "person" means all domestic and foreign corporations, cooperative corporations, associations, syndicates, partnerships of every kind, joint ventures and individuals or societies of individuals transacting and carrying on any business in the City of Wilsonville, Oregon.

B. As used in this Ordinance "business" means any profession, trade or occupation carried on for a livelihood or profit, when the annual gross income of such business exceeds the sum of Five Hundred Dollars (\$500.00); but not including, however, the following:

1. Suppliers to retailers and those engaged in wholesale selling, who do not have a place of business in the City of Wilsonville.

2. Municipal, State or Federal agencies or employees.

3. Any person employed in the City of Wilsonville by one engaged in business in the City of Wilsonville, if

the employer is licensed pursuant to this Ordinance to conduct a business in the City of Wilsonville, otherwise such persons shall themselves be deemed to be engaged in business and subject to the requirements of this Ordinance.

4. Any person transacting and carrying on any business which is exempt from a license tax by virtue of the Constitution of the United States, the Constitution of the State of Oregon, or the laws of the United States or the laws of the State of Oregon.

5. Any person engaged as a landlord in leasing property, unless such person leases at any one time more than two (2) separate rental units or parcels, whether it be land or buildings, or both, or residential or commercial, or both, in which event, if his annual gross income from rentals exceeds \$500.00, such person shall be deemed to be engaged in business."

"Section 3:

A. No person who is required to be licensed under the provisions of this Ordinance shall engage in business in the City of Wilsonville until he has paid a license fee.

B. The annual license fee for each fiscal year commencing July 1, 1973 shall be \$30.00 payable on or before July 15th.

C. The license fee for the period January 1 to July 1 in any year hereafter shall be \$15.00 payable on or before January 15th; and the annual license fee as required by the foregoing subsection "B" shall be paid thereafter for each year or fraction thereof that the licensee continues in business in the City of Wilsonville and is otherwise subject to the requirements of this Ordinance.

D. The license fees prescribed in the foregoing subsections B and C shall be paid to the Wilsonville City Recorder upon the filing of an application for a business license or upon the annual renewal of a business license.

E. Each branch establishment of any business for the purpose of this Ordinance shall be considered a separate business and subject to the license therefor, as herein provided, but a warehouse or storage building used solely in connection with the business licensed and operated by the person conducting such business shall not be considered a separate business or branch establishment."

<u>Section 2:</u> This ordinance shall take effect and the increased license fees shall be applied commencing at the hour of 12:01 o'clock A.M., Oregon Daylight Saving Time, on Sunday, July 1, 1973.

Passed on first reading at a regular meeting of the Wilsonville City Council held on the 11th day of June, 1973; ordered posted in three public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter, and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof to be held on the 25th day of June, 1973, at the hour of 7:30 o'clock P.M., Oregon Daylight Saving Time, at the Council's regular meeting place in the Wilsonville City Hall.
