ORDINANCE NO. 101

AN ORDINANCE AUTHORIZING EMPLOYMENT CONTRACT WITH WESTECH ENGINEERING, INC. FOR ENGINEERING SERVICES FOR CITY CENTER ROADWAY LID #2.

WHEREAS, the City of Wilsonville has created the City Center Roadway

Local Improvement District #2 and directed the engineering firm of Westech

Engineering, Inc. to prepare detailed plans, specifications and cost estimates

for said improvement project; now, therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: An Agreement for engineering services by Westech Engineering, Inc. of Salem, Oregon, for preparation of detailed plans, specifications and cost estimates for the City Center Roadway Local Improvement District #2 and for other engineering services related to the completion of that project is hereby approved, and a copy of the approved Agreement is attached hereto marked "Exhibit A" for identification purposes and by this reference and its attachment is expressly made a part of this Ordinance.

Section 2: The Mayor whose signature is to be attested by the City Recorder is authorized and directed to execute and deliver the said Contract referred to in Section 1 above in the name of and on behalf of the City of Wilsonville and in as many counterparts as may be required; and payment of the engineering fees as specified by said Contract and approved by this Ordinance are to be made on receipt of billings from the assessments to be collected from the benefited property owners or the proceeds of a Bancroft bond issue which may be sold to pay the costs of the improvements for said project. Pending receipt of assessments from the owners of benefited properties and/or the sale of Bancroft bonds to finance said project, payments of said engineering fees and Contract are to be made from any contingency fund of the City as budgeted and which may properly be used for payment of said account and as may be approved by the City Council. Payments from any reserve account are to be reimbursed with simple interest at the legal rate upon receipt of payments for assessments to be made or from the proceeds of a Bancroft bond issue, and whichever occurs first.

Passed on first reading of the Wilsonville City Council at a meeting thereof on the 17th day of April, 1978; ordered posted as provided by the Wilsonville City Charter, and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof on the 1st day of May, 1978, at the hour of 8:00 o'clock p.m. at the Council's usual meeting place at the Wilsonville Grade School.
