## ORDINANCE NO. 102

AN ORDINANCE AUTHORIZING CONTRACT FOR CONSTRUCTION OF CITY WATER SYSTEM IMPROVEMENTS--SCHEDULE A; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Wilsonville has heretofore advertised for and received bids for the construction of City water system improvements commonly referred to as "Charbonneau Phase A Water System" according to plans and specifications prepared for such project by Westech Engineering, Inc., consulting engineers and planners of Salem, Oregon; and

WHEREAS, the NOTICE OF CALL FOR BIDS was duly and regularly given in the manner and for the time required by law, and bids were received, opened, read and considered by Westech Engineering, Inc. on March 30, 1978, which made its written report and recommendation to the City Council on April 3, 1978; and

WHEREAS, four bids were received as follows:

WHEREAS, the Wilsonville City Council, as the City's Contract Review Board, on April 3, 1978, considered the bids and the recommendations of the City engineer, and has determined that the lowest and best bid was that of Schneider Equipment, Inc.; and

WHEREAS, the low bid exceeds the City engineer's estimate but in view of the rapidly increasing costs of labor and material and the importance of starting work before the onset of fall rains and winter weather, the Council has determined that it is necessary and advisable to accept the low bid and proceed immediately with the construction project; now, therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: An emergency is hereby declared to exist, and the Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville and on its behalf a Contract with Schneider Equipment, Inc. for the construction of the City water system improvements commonly referred to as "Charbonneau Phase A Water System" and according to

the plans and specifications for said project as prepared by Westech Engineering, Inc. and any changes or modifications of those plans and specifications and which said plans and specifications are now on file in the office of the City Recorder; and

Section 2: The bid of Schneider Equipment, Inc. in the total amount of \$141,630.57 is hereby approved as the amount of said Contract and is to be paid upon receipt of billings and approval of the City's engineer and City Council from the proceeds of the City's water bond issue sold January 3, 1978.

Section 3: Because of the emergency herein declared to exist and the urgent need for the water system improvements, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a regular meeting of the Wilsonville City Council on the 17thday of April , 1978; ordered posted as provided by the Wilsonville City Charter; and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof on the 1st day of

May , 1978, at the hour of 8:00 o'clock p.m. at the Council's usual meeting place at the Wilsonville Grade School.
