ORDINANCE NO. 108 AN ORDINANCE AUTHORIZING EMERGENCY PURCHASE OF TANKER TRUCK FOR SLUDGE REMOVAL

WHEREAS, the accumulation of sludge at the City's Sewage Treatment Plant has become a serious problem, which threatens the health and general welfare of the City's residents. Many have complained of offensive odors and the possibility of contagion disease will increase with hot summer weather; and

WHEREAS, the City Council and staff have endeavored for several weeks to obtain sludge removal services from independent contractors, but without success and a used sludge tanker truck has been located and is available for purchase from the only known source of such equipment; and

WHEREAS, City Officers and Staff have inspected the equipment and determined its price and made a favorable report to the City Council; now therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: The accumulation of sludge at the City's Sewage Treatment Plant and lack of means for its removal, except by City work force and equipment, has created an emergency, which is hereby declared.

Section 2: Purchase is hereby authorized without bids of one 1971 model Ford Tank Truck, Serial Number SN 907VJ64561, now owned by Ballard Motors at 4821 S. W. Highway 101, Lincoln City, Oregon 97367, and for a purchase price of \$24,600.00.

Section 3: The Mayor is authorized to sign a purchase order; and the purchase price shall be paid upon delivery and final satisfactory inspection of the equipment with City funds in the 1978-79 Budget, Line Item No. 7, in the Sewer Department Account.
