## ORDINANCE NO. 110

AN ORDINANCE AUTHORIZING CONTRACT FOR REPLACEMENT OF WATER MAINS IN "OLD TOWN"; AND DECLARING AN EMERGENCY

WHEREAS, the City of Wilsonville has heretofore advertised for and received bids for the replacement of water mains in the "Old Town" section of the City according to plans and specifications prepared for such project by Dorner and Tunks, Inc., Engineers of Portland, Oregon; and

WHEREAS, the NOTICE OF CALL FOR BIDS was duly and regularly given in the manner and for the time required by law. Publications were made in the Daily Journal of Commerce on May 22 and May 29, 1978 and also in the Tigard Times on May 24 and May 31, 1978. Bids were received, opened, read and considered at 3:00 o'clock p.m. at the Wilsonville City Hall on June 15, 1978. Mr. William Dorner of the engineering firm appeared and made his report and recommendation to the City Council at a regular meeting on June 19, 1978 and further consideration was given at a special meeting on July 10, 1978; and

WHEREAS, three bids were received as follows:

WEREAS, the Wilsonville City Council, as the City's contract review board on July 10, 1978 considered the bids and recommendation of the City's engineer and determined that the lowest, best and acceptable bid was that of Keith Taylor Const., Inc. of 2535 N.W. Upshur St., Portland, Oregon; and

WHEREAS, the low bid exceeds the engineer's estimate which was \$52,290.00 but in view of the rapidly increasing costs of labor and material and the urgency of starting work before the onset of fall rains and winter weather, the Council has determined that it is necessary and advisable to accept the low bid and proceed immediately

with the construction project; now, therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: An emergency is hereby declared to exist and the Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville and on its behalf a contract with Keith Taylor Const., Inc., of Portland, Oregon for the replacement of water mains in the "Old Town" section of the City of Wilsonville and according to the plans and the specifications for said project as prepared by Dorner and Tunks, Inc., Engineers of Portland, Oregon and any changes or modifications of those plans and specifications which may be authorized by change orders of the City Council and which said plans and specifications are now on file in the office of the City Recorder; and

Section 2: The bid of Keith Taylor Const., Inc. in the total amount of \$64,995 is hereby approved as the amount of said contract and is to be paid upon receipt of billings and approval of the City's Engineer and the City Council from the proceeds of the City's water bond issue sold January 3, 1978.

<u>Section 3</u>: Because of the emergency herein declared to exist and the urgent need for the water system improvements, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a special meeting of the Wilsonville City Council on the 17th day of July, 1978; ordered posted as provided by the Wilsonville City Charter; and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereon on the 10th day of August, 1978 at the hour of 8:00 o'clock p.m. at the Wilsonville Tektronix Plant, Room S-1.
