ORDINANCE NO. 122 AN ORDINANCE AUTHORIZING EMERGENCY PURCHASE OF 1979 MODEL DODGE PICKUP TRUCK FOR CITY BUSINESS WHEREAS, the City has no motor vehicle for City use by the Building Inspector or other City employees requiring transportation on official City business. The City has been renting a truck for necessary use of the Building Department; and other City officials have been using their private cars for necessary City business, which has become an impossible arrangement to continue; and WHEREAS, the urgent need for the immediate acquisition of a City-owned vehicle is imperative and an emergency exists; and WHEREAS, City staff has located a new Dodge pickup truck at a reasonable price for immediate purchase and delivery and funds are available in the City's current budget for such acquisition; now therefore. THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS: Section 1: The immediate and future need for a City-owned vehicle for official City business is required and an emergency is hereby declared to exist. Section 2: Purchase is hereby authorized without bids of one (1) 1979 Model D200, Dodge, Sweptline, 3/4 ton pickup truck now owned by Meyer Bros., Chrysler/Plymouth, at 2809 Portland Road, Newberg, Oregon, for a purchase price of \$6,060, including freight, but not including license and transfer of title costs. Section 3: The Mayor is authorized to sign a purchase order and the purchase price shall be paid upon delivery and final inspection of the vehicle with City funds in the 1978-79 budget, General Contingency Line Item.
