## ORDINANCE NO. 141

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 132 ENACTED SEPTEMBER 4, 1979, AUTHORIZING CONTRACT FOR CONSTRUCTION OF BOECKMAN CREEK TRUNK SEWER AND AUTHORIZING ISSUANCE OF GENERAL OBLIGATION WARRANTS FOR INTERIM FINANCING.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: Section 3 of Ordinance No. 132 enacted September 4, 1979, is hereby amended to provide as follows:

Section 3: The City of Wilsonville is authorized to issue, and the Mayor and City Recorder are authorized to execute and deliver in the name of the City, GENERAL OBLIGATION IMPROVEMENT WARRANTS for interim financing and evidencing an indebtedness for construction of the public improvements in the Boeckman Creek Sewer Improvement District (LID #3). Such warrants shall be in the aggregate amount of Three Hundred Thousand Dollars (\$300,000) payable on or before two (2) years after the date thereof to the order of the FIRST NATIONAL BANK OF OREGON, Wilsonville Branch, Wilsonville, Oregon, together with interest thereon from the date of issue to the time when called for payment, at a rate not exceeding 7.75 percent per annum. The GENERAL OBLIGATION IMPROVEMENT WARRANTS hereby authorized are pursuant to the provisions of ORS 287.502 to 287.510, inclusive, and shall constitute a general obligation of the City of Wilsonville."
