ORDINANCE NO. 145 AN ORDINANCE AUTHORIZING CONTRACT FOR EMERGENCY REPAIRS TO BOECKMAN ROAD. WHEREAS, the slope on the south side of Boeckman Road in the City of Wilsonville is collapsing due to a rain saturated fill over the culvert crossing under Boeckman Road and immediate repairs are required to protect the public and insure the safety of motorists or other users of that road; and WHEREAS, there is not sufficient time to advertise for competitive bids and the City Council authorized the engineering firm of Westech Engineering, Inc. of Salem, Oregon to obtain quotes for necessary repairs and it did and reported as follows: \$22,769 King Construction Beaver State Construction \$16,972 \$17,798 Eyman Construction Now, therefore, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS: Section 1: The quote of Beaver State Construction in the amount of \$16,972 is accepted for the necessary repairs to correct the slope failure on Boeckman Road; and necessary repairs are to be made immediately under supervision and direction of Westech Engineering, Inc. Section 2: The Mayor and City Recorder are authorized and directed to make, execute and deliver a construction contract with said company on behalf of the City of Wilsonville, and for payment of the quoted amount upon receipt of billings and approval by the engineers and the City Council. Section 3: The cost of repairs hereby authorized are to be paid from line item #16 in the City's Road Fund Reserve of the current budget; and any additional costs that are unforseen but which may be incurred in order to make all necessary repairs are also to be paid from that budget item. If there are not sufficient funds budgeted in this fiscal year for these emergency road repairs Page 1. ORDINANCE NO. 145,

the Mayor is authorized to negotiate a loan for the City to pay any deficiencies which will be repaid with resources from the next years budget.
