

State of Oregon, being first duly sworn on oath depose and say:


On the 31st day of January, 1980, I caused to be posted copies

ORDINANCE NO. 147

AN ORDINANCE AUTHORIZING PAYMENT OF COSTS FOR EMERGENCY PURCHASES FROM TIGARD SAND AND GRAVEL CO. FOR REPAIRS OF BOECKMAN ROAD.

WHEREAS, the Council enacted Ordinance No. 145 on January 7, 1980, entitled " AN ORDINANCE AUTHORIZING CONTRACT FOR EMERGENCY REPAIRS TO BOECKMAN ROAD"; and

WHEREAS, during the course of the construction of the repair project as authorized by said Ordinance, emergency purchases of additional materials and supplies from Tigard Sand and Gravel Co. became necessary and the City Administrator was authorized to make the required purchases as an emergency measure which was necessary to safeguard and protect the health, safety, peace and general welfare of the citizens of Wilsonville and the public generally, and particularly the users of Boeckman Road, which was extensively damaged by winter weather; and


WHEREAS, the emergency purchases of materials and supplies from Tigard Sand and Gravel Co. totaled \$11,089.88 and should be paid on receipt of billing since the materials were furnished, were completely satisfactory for the job as required, and were utilized in the emergency repairs and reconstruction of the weather damaged portions of Boeckman Road; now therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: The bill of Tigard Sand and Gravel Co. in the sum of \$11,089.88 for materials and supplies furnished for the emergency repairs of Boeckman Road is hereby approved; and payment thereof is hereby authorized to be made from the proceeds of a short term loan which the Mayor was authorized to negotiate for the City for such purposes by Ordinance No. 145 enacted on January 7, 1980.

second reading at a regular meeting of the council on the 4th
day of February, 1980, commencing at the hour of 7:30 o'clock
P. M. at the Wilsonville City Hall
