ORDINANCE NO. 166

AN ORDINANCE REPEALING ORDINANCE NO. 129 (PROHIBITS PARKING WITHIN SPECIFIED AREA OF PARKWAY AVENUE) AND DECLARING AN EMERGENCY.

WHEREAS, the City Council had adopted Ordinance
No. 133, establishing itself, along with its appointees, as
a Traffic Control Commission with the power to regulate
traffic and traffic safety problems by order; and

WHEREAS, the Traffic Control Commission is desirous of adopting, upon hearing, findings and order, certain regulated parking within the prohibited area of Parkway Avenue and maintaining the prohibition of no parking for the remaining area and may desire to modify same from time to time in the future; and

WHEREAS, the existence of Ordinance No. 129 is no longer of necessity in view of Ordinance No. 133 and the function and activities of the Traffic Control Commission.

NOW, THEREFORE,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. That Ordinance No. 129: "AN ORDINANCE PROHIBITING PARKING WITHIN SPECIFIED AREA OF PARKWAY AVENUE, PRESCRIBING PENALTY, AND DECLARING AN EMERGENCY," is hereby repealed in its entirety.

Section 2. That inasmuch as there needs to be coordination between the City Council and the Traffic Control Commission to maintain the traffic regulation of Parkway Avenue for the health, safety and general welfare and to avoid confusion as to the jurisdiction of the respective governmental bodies, an emergency is hereby declared to exist and this Ordinance shall take effect immediately upon its final reading and enactment.

Submitted to the Council and read the first time at a regular meeting thereof on the 20th day of October, 1980, and scheduled for second reading at a regular meeting of the Council on the 17th day of November, 1980, commencing at the hour of 7:30 o'clock P.M. at the Wilsonville City Hall.
