Sandy:

I question whether our WES contract expires in 2013. Here's why:

According to TriMet, WES service started February 2, 2009.

We have a 20-year contract signed on March 28, 2006. (Section 23 of the Agreement.) Instead of expiring, it contains a formula for revising the amount to be paid by Wilsonville to TriMet after the first five years of WES service. According to the agreement, the five year \$300,000 annual cap began in <u>July, 2009</u> – the beginning of the first full fiscal year of revenue service. (Section 4, A. of the Agreement.)

I believe that puts the end of the five-year period at June 30, 2014.

I will copy this to Mike, Bryan and Steve in case they interpret these things differently. I have been operating under the assumption that we will begin negotiations with TriMet in 2013, but we continue to make payments of \$300,000/year until the beginning of fiscal year 2014/15. Anyway, I certainly hope I've got this right.

I went through minutes as well searching for anything transit related and here are the notes I came up with. I seem to recall on more than one occasion that members mentioned the benefits of transit and WES for getting employees to Wilsonville, but don't recall who. We do have all the meetings recorded if we need to have someone go through them and listen for this.

4-19 minutes

• The positive energy around OIT was encouraging. Transit is important for OIT because students are likely to use transit. A big issue is how to get students to the campus, especially after work. Transit is one of the solutions to this issue.

Focus groups

Transit. Participants noted the importance of transit for moving workers, especially as an alternative for
automotive commuting. They said that increasing transit capacity is important for maintaining capacity for
moving freight on I-5. Several participants said that local transit does not operate frequently enough throughout
the day, serves too few hours on weekdays, and does not operate enough on weekends; limited transit service
makes reliance on transit as a primary transportation mode more difficult.

Summit

- Consider land use policies, such as a zoning overlay district, that would allow office development to occur within industrial areas at key transit station areas.
- SMART is well-done. It is a business magnet that provides good connections to other transit systems and other communities.
- Rail lines in Wilsonville connect to other areas in the Metro Region. They provide untapped opportunities for commuter rail with connections via WES, SMART, TriMet.
