## **ONGOING BUSINESS/CALENDAR ITEMS**

- **1. Youth Services Report** Olivia Jensen reported youth events are still online on the second and fourth Fridays of the month at 6 PM. On 12<sup>th</sup>, they will be doing Connect 4 and on the 26<sup>th</sup>, they will be doing online minigames. TAB meets Tuesdays at 4 PM and will start planning more events at their next meeting.
- **2. Librarians Report** Pat Duke reported the library is continuing being open 20 hours a week. Three new on call clerks have been hired to refresh the pool. This is especially helpful as the library has been short staffed recently due to quarantines and Covid.
- **3. FY22 Budget** Pat Duke turned in a budget to the city with no significant changes. Due to the situation, there has been no revenue from circulation and currently the library is down \$40,000 which is being accommodating by reducing the materials budget. This should be fixed by the next fiscal year.
- **4. Anniversary of the Library** Pat Duke reported there will be no events this year to celebrate but as next year is the 40<sup>th</sup> anniversary, there will be a celebration then.
- **5. OLA Conference Sign-Ups** Pat Duke informed the board the OLA conference will be online this year April 20-23 and if members are interested, the library can sign them up.
- **6. Strategic Plan** Pat Duke reported there is currently no progress, though he has been talking with Steven Engelfried and Shasta Sasser about it.
- **7. Policies and Procedures** The board voted to approve the Restricted Materials policy that Molly wrote up. Pat Duke introduced a draft of the new collection development policy and will share more when there is a more fleshed out version.

- **8. Friends of the Library Report** Pat Duke reported the Friends met today and passed the new bylaws which include reducing board positions and taking the voting element out of membership.
- **9. Library Foundation Report** Caroline Berry reported the Foundation had elections and is keeping the same officers. They are doing a survey on how the last year has gone and what they want to do this year. They are also having an information meeting via Zoom on Friday for prospective members.
