#### **RESOLUTION NO. 2868**

#### A RESOLUTION OF THE CITY OF WILSONVILLE ESTABLISHING A RESTAURANT RELIEF PROGRAM TO ADDRESS IMPACTS ASSOCIATED WITH COVID-19.

WHEREAS, since January 2020, the State of Oregon has been engaged in responding to the public health threat posed by the novel infectious coronavirus (COVID-19); and

WHEREAS, as the threat escalated, the State's response elevated to meet the threat; and

WHEREAS, on March 8, 2020 Governor Brown declared a state of emergency and directed immediate response action; and

WHEREAS, on March 23, 2020 Governor Brown ordered Oregonians to "Stay Home, Save Lives," directing citizens to stay home to the greatest extent possible and among other things ordered the closure of specified retail businesses, including restaurants; and

WHEREAS, the World Health Organization (WHO) has declared the C-19 outbreak a global pandemic and the President of the United States declared a national emergency; and

WHEREAS, on November 17, 2020 Governor Brown enacted Executive Order 20-65 a Temporary Freeze to Address Surge in COVID-19 Cases in Oregon again directing food and drink establishments to stop on-premises consumption of food or drink, inside or outside; and

WHEREAS, according to KOIN News 6, an informal survey of independently owned restaurants indicates that the loss of indoor dining results in a revenue loss on average of 81.75%, forcing closures and mass layoffs; and

WHEREAS, the City Council desires to minimize this crisis locally and in doing so has created a Restaurant Relief Program to assist brick and mortar restaurants sustain the shut downs associated with the C-19 pandemic.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The City Council incorporates and adopts the above recitals as if fully set forth herein.
- 2. The City Council hereby adopts Resolution No. 2868 establishing a Restaurant Relief Program in the amount of \$80,000.
- 3. The Restaurant Relief Program is described in in Exhibit A.
- 4. The City Council directs staff to distribute the allocated funds immediately in two groups, with \$50,000 being divided evenly amongst the 22 sit-down, full-service establishments

(\$2,272.72 each), and \$30,000 being divided evenly amongst the 29 general take-out, self-service restaurants (\$1,034.48 each), as defined on Exhibit B, attached hereto.

5. This Resolution becomes effective upon adoption.

ADOPTED by the Wilsonville City Council at a regular meeting thereof this 7<sup>th</sup> day of December, 2020, and filed with the Wilsonville City Recorder this date.

# Wilsonville Restaurant Relief Program

### Overview

The City of Wilsonville recognizes the devastating effect of the COVID-19 crisis on many of our local businesses, specifically the sit down restaurant industry, and is committed to identifying solutions that provide relief and restore the health of our business community. In this spirit, the City will provide financial assistance totaling \$80,000 to help restaurateurs overcome the temporary loss of revenue and disruption from the COVID-19 crisis.

## Description

The Wilsonville Restaurant Relief Program was developed to offer immediate financial assistance to the 51 brick and mortar sit down restaurants in the community. The impetus for the program came from a mini-task force of 3-people, including City Community Development Staff, Councilor Joann Linville, and Wilsonville Area Chamber of Commerce CEO Kevin O'Malley, and approved by City Council on December 7, 2020.

### **Mandatory Criteria**

- ✓ Business must have a current City of Wilsonville business license.
- ✓ Business must have a brick-and-mortar/physical facility located in the City of Wilsonville.
- ✓ Business will have to provide a Form W-9 to the City's Finance Department.
- ✓ Funds must be used for Business Operations only.

## Excluded

- ✓ Food establishments that have yet to officially open at the time of program adoption.
- ✓ Fast-food, drive-through restaurants are not eligible.
- ✓ Mobile food trucks are not eligible.

### **Grant Size**

- ✓ Projected amount for the 22 full-service sit-down restaurants is \$2,272.72 (50,000/22) per restaurant.
- ✓ Projected amount for the 29 general take-out, self-service restaurants is \$1,034.48 (30,000/29) per restaurant.

## **Program Application**

Funds will be dispersed to eligible restaurants on as soon as the Finance Department is able to process payment.
