ORDINANCE NO. 537

AN ORDINANCE AMENDING CHAPTER SEVEN OF THE WILSONVILLE CODE, PERTAINING TO PEDDLERS AND SOLICITORS, TO INCLUDE NEW SECTION 7.020(k), REQUIRING APPLICANT TO PROVIDE PHOTOGRAPHS WHEN APPLYING FOR A SOLICATION LICENSE.

WHEREAS, the Wilsonville City Council adopted Ordinance No. 495, entitled "An Ordinance Regulating Peddlers And Solicitors, Prohibiting Solicitation Without A License, Repealing Wilsonville Code, Sections 7.000, Prohibition, And 7.010, Penalty, And Amending Chapter 7 Of The Wilsonville Code By Adding New Sections 7.000 To 7.010", in January, 1998. WHEREAS, Section 7 of the Wilsonville City Code enables the citizens of this City to benefit from the quiet enjoyment of their residences and allows businesses located within its boundaries to conduct their businesses without undue interference, including being protected from unwelcome disturbances and disruptions of privacy, and also protects the City" citizens from unusual activity, such as fraud and abuse, while allowing peddlers and solicitors to carry out their lawful business within the City; and

WHEREAS, the City Council finds that under the existing requirements persons may unlawfully transfer their permits and those persons receiving and using such permits are often difficult to properly identify from the original permittee; thereby, causing further difficulties in enforcing provisions of Section 7 against; and

WHEREAS, the City Council, therefore, finds that the existing requirements are open to abuse and disregard, and that adoption of a photograph identification is a reasonable means to deter such abuse and that for the applicant to obtain and present two, two inch by two inch photographs of oneself does not impose an unreasonable burden on commerce, travel, speech or association.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. Wilsonville Code, Peddlers and Transient Merchants, Section 7.020, Application, is hereby amended to include the following:

7.020(k) Application.

(k) Two (2) Photographs of the applicant which shall have been taken within sixty (60) days immediately prior to the date of the filing of the application. The photographs shall measure two (2) inches by two (2)

inches and show the head and shoulders of the applicant in a clear and distinguished manner.
