ORDINANCE NO. 630

AN ORDINANCE OF THE CITY OF WILSONVILLE AMENDING W.C. 1.012, FINES FOR VIOLATION, TO INCREASE THE MAXIMUM AMOUNT OF A FINE AND MAKE EACH DAY THE VIOLATION PERSISTS A SEPARATE OFFENSE.

WHEREAS, with inflation and an increase in the cost of maintaining the City, it is reasonable to raise the maximum penalty amount that can be assessed for violation of the Code from the amount set in 1984; and

WHEREAS, the City desires that each day a violation persists to be treated as a separate violation, with a separate assessment;

NOW THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. Wilsonville Code section 1.012 is hereby amended to read as follows:

W.C. 1.012. Fines for Violation.

-[(1) A sentence to pay a fine for a violation shall be a sentence to pay an amount fixed by the court, not exceeding \$250.00.]

Any person sentenced to pay a fine for a violation, unless provision is otherwise made herein, shall upon conviction thereof, be punished by a fine, fixed by the court, not exceeding \$500. However, no greater penalty shall be imposed than the penalty prescribed by the Oregon statute for the same act or omission. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of this Code is committed, continued, or permitted by such person and may be punished accordingly.

Introduction

An important aspect of the City Code is to provide for an enforcement mechanism in the event of a code violation. The simplest enforcement tool is the ability to assess a reasonable fine for a violation. In 1984, Wilsonville adopted W.C. 1.012 which provides:

"a sentence to pay a fine for a violation shall be a sentence to pay an amount fixed by the court, not exceeding \$250.00."

This memo serves to raise two issues. First, staff proposes that the maximum fine amount should be increased from \$250.00 to \$500.00. Second, the structure of W.C. 1.012 limits the assessment of fines to code sections that specifically designate "violations of such code sections shall be punished pursuant to" W.C. 1.012. Not all Code sections provide for punishment pursuant to W.C. 1.012. Those that do not may not be assessed a fine when they are violated. We wish to bring this to your attention and explain the process we are undertaking to ensure that each code section has an appropriate remedy for its violation. We also present an alternative structure for W.C. 1.012 such that violation of any code section may result in assessment of a fine.

(1) Maximum Fine Per Day

The current maximum fine for Wilsonville is \$250.00, set in 1984. Comparable maximum penalties of surrounding municipalities are:

Many violations of the Code rely on the fine amount designated in W.C. 1.012. For fines for the violation of Tree Preservation and Protection (4.640), Transient Lodging Tax

(7.280), Business Licenses (7.370), and Garbage Disposal (8.152) are all capped by W.C. 1.012's \$250.00 maximum. Some sections provide a lower maximum, such as W.C. 4.156(.12), Sign Regulations, which provides violations are not to exceed \$100.00 per day. For certain violations, \$250.00 may not provide strong enough deterrence for individual's to forgo the violation. Additionally, Staff is in the process of amending the Nuisance Code to allow for citation in the event of a nuisance. For egregious nuisances such as toxic substances, or health and safety hazards, the City wants to provide a strong incentive for individual's to abate the nuisance immediately.

Staff believes that a \$500 maximum is an amount with sufficient deterrence presence to reduce code violations. We do not believe we need to provide for Class's of violations like the City of Beaverton because this would be a large administrative expense to categorize violations according to Class and we feel confident that we can rely on our court to make appropriate fine determinations based on the egregiousness of the violation.

As the Code is currently written, it is unclear whether each day acts as a separate violation. We clarify that each day a violation persists is a separate violation through the proposed amendment below.

Deletions are shown in bracketed strikethrough language and additions are shown in bracketed bold and underlined language:

<u>W.C. 1.012. Fines for Violation.</u> [(1) A sentence to pay a fine for a violation shall be a sentence to pay an amount fixed by the court, not exceeding \$250.00.]

Any person sentenced to pay a fine for a violation, unless provision is otherwise made herein, shall upon conviction thereof, be punished by a fine, fixed by the court, not exceeding \$500. However, no greater penalty shall be imposed than the penalty prescribed by the Oregon statute for the same act or omission. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of this Code is committed, continued, or permitted by such person and may be punished accordingly.

W.C. 1.012 Limitations

This phrase has acted as our "catch all" code section to assess a fine in the event of a code violation. It provides for assessment of a fine for violation of a code section only for violation of code sections that specifically call for a fine to be assessed. For example, Chapter 5, Section 5.030 provides fines to be assessed for a violation of Chapter 5, as designated by W.C. 1.012.

However, not all chapters provide that violation of a chapter provision results in punishment or assessment in a fine. When a code section does not provide for paying a fine upon violation, W.C. 1.012 is powerless. For example, when an individual creates a nuisance, the City must go through summary abatement procedures. The City cannot assess a fine for each day the nuisance persists.

The ability to assess daily fines for code violations creates a powerful incentive for people to remedy code violations as soon as possible. We are in the process of evaluating all sections of the Code to ensure enforcement provisions requiring payment of a fine are in place for each Code section.

Other municipalities, such as the City of Portland, provide that "It is unlawful to violate any provision or to fail to comply with any requirement of this Code. Any person violating any provision or failing to comply with any requirement of this Code, unless provision is otherwise made herein, shall upon conviction thereof, be punished by a fine of not more than \$500."

The above structure is an efficient and immediate method of ensuring that the City has the authority to assess a fine in the event of a violation, even where code sections do not specify as such. The rationale is that the Code is a set of rules for the residents, visitors, and businesses to abide by. Therefore it should be expected that a violation of any of its sections may result in a reasonable fine. However this structure also opens the possibility for abuse such that procedural violations, such as failure to submit complete applications for Site Development Permits (W.C. 4.035(.05)) are technically vulnerable to a fine.

Recommendation

Staff recommends amending W.C. 1.012 as described above and invite your comments as to whether the City Code should provide authorization to assess a fine for any code violation.
