ORDINANCE NO. 88

AN ORDINANCE AUTHORIZING EXECUTION OF A CONTRACT FOR CONSTRUCTION OF SEWAGE TREATMENT PLANT EXPANSION.

WHEREAS, the City of Wilsonville has heretofore advertised for and received bids for its planned sewage treatment plant expansion according to plans and specifications prepared by the engineering firm of CH2M Hill; and

WHEREAS, the NOTICE OF CALL FOR BIDS was duly and regularly published in the Daily Journal of Commerce on August 31, September 2 and September 6, 1977 and also in the Tigard Times on September 7 and 10, 1977; and

WHEREAS, the bids as advertised were received and publicly opened at the City Hall on Thursday, September 29, 1977 and Seven (7) bids were received as follows:

WHEREAS, the Wilsonville City Council as the City's Contract Review Board on October 3, 1977, considered the bids and the recommendations of the City Engineer and has determined that the lowest and best bid was that of R. L. Martin, Inc.; and

WHEREAS, the low bid only exceeds by \$38,085 the Engineer's estimated cost of \$462,000, but in view of the rapidly increasing costs of labor and material and the importance of starting work before the onset of fall rains and winter weather, the Council has determined that it is necessary and advisable to accept the low bid and proceed immediately with the construction project; and that most of the funds for payment of the contract are available in the Sewer Reserve Fund and sufficient additional funds will be available before the work is complete from accruals to that fund or sale of Sewer Bonds which were previously authorized by the city voters; now therefore,

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: An emergency is hereby declared to exist, and the Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville and on its behalf, a Contract with the R. L. Martin, Inc. for the construction of the sewage treatment plant expansion according to the plans and specifications for such project which are now on file in the office of the City Recorder and in the amount of \$423,915 which includes the following selected equipment:

- 1. Treatment Unit: Can-Tex \$62,200.
- 2. Auto Backwash Filter: Envirotech 53,135.
- 3. Self-prime Pumps: Peabody Barnes 9,100.

<u>Section 2</u>: The Contract price for the project shall be paid upon receipt of billings and approval by the City's Engineer and the City Council from Sewer Reserve funds.

<u>Section 3</u>: Because of the emergency herein declared to exist and the urgent need for the sewage treatment plant expansion, this Ordinance shall take effect immediately upon its enactment after final reading.

Passed on first reading at a recessed regular meeting of the Wilsonville City Council on Tuesday, October 4, 1977; ordered posted in three (3) public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter; and to come up for final reading and action of the Wilsonville Council at a special meeting thereof to be held on Tuesday, October 25, 1977, at the hour of 7:30 o'clock p.m. at the Wilsonville Grade School.
