ORDINANCE NO. 183

AN ORDINANCE AUTHORIZING CONTRACT PURCHASE OF NEW 88 INCH FLAIL MOWER AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to specifications prepared by the City of Wilsonville's Public Works Director, Larry Blanchard, the City of Wilsonville duly called for bids for a new 88 inch flail mower; and

WHEREAS, the City of Wilsonville received three bids and the results of the bidding reported to the Mayor and Wilsonville City Council by Memorandum of May 12, 1981, of Public Works Director, Larry Blanchard, as follows:

Auto Farm & Garden Equipment of Sherwood – 88" Flail Mower	\$2,170.00
Yeager Ford Tractor 88" Flail Mower	\$1,871.00
Lenon Implement Tractor Co. 74" Flail Mower (not to specifications)	\$1,650.00

The May 12, 1981, Memorandum went on to recommend that the low bid of \$1,871.00 from Yeager Ford Tractor be accepted, but since the total budget for this item was \$1,500.00, that the balance of \$371.00 be taken from the park contingency fund; and

WHEREAS, the City Council/Contract Review Board has considered the bids, the specifications on said equipment, and the report and recommendation of its Public Works Director and de-

termined that the low bid for the 88 inch flail mower is that of \$1,871.00 from Yeager Ford Tractor.

THE CITY OF WILSONVILLE ORDAINS, as follows:

Section 1: The bid of Yeager Ford Tractor for an 88 inch flail mower in the amount of \$1,871.00 is hereby accepted in accordance with the specifications as prepared by the Public Works Director. The excess of \$371.00, over the budgeted figure of \$1,500.00, shall be transferred from the park contingency fund.

Section 2: The Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville on its behalf a contract with Yeager Ford Tractor for the purchase of an 88 inch flail mower, according to the specifications therefor, and any changes or modifications of those specifications as may be approved by the City Council and which said specifications are now on file in the office of the City Recorder.

Section 3: Payment by the City of Wilsonville of the purchase contract authorized in the above are to be made according to the schedule of payments as outlined in the contract purchase document.

<u>Section 4</u>: In order that this equipment come on line to provide efficient, timely and cost effective services to the citizens of Wilsonville, an emergency is hereby declared to

exist, and this Ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.
