ORDINANCE NO. 186

AN ORDINANCE AMENDING NUISANCE ORDINANCE NO. 69

IT IS HEREBY ORDAINED BY THE CITY OF WILSONVILLE that the City of Wilsonville Ordinance No. 69, An Ordinance Defining Nuisances; Providing for Their Abatement; and Prescribing Penalties for Violations, is hereby amended so that its Section 1.01 4. 2. shall now read:

Sounds originating on construction, demolition and/or 2. logging sites and reasonably necessary to the accomplishment of work and progress during the hours of 7:00 a.m. to 8:00 p.m. Pacific Standard Time, Mondays through Fridays, and 7:00 a.m. through 9:00 p.m. Pacific Daylight Time, Mondays through Fridays, and 9:00 a.m. to 6:00 p.m. Pacific Standard Time on Saturdays and 9:00 a.m. to 7:00 p.m. Pacific Daylight Time on Saturdays. Any sounds originating on construction, demolition and/or logging sites outside of the aforementioned days and times shall be prima facie evidence of noise unreasonably offensive to the public, save and except, if the City's Administrator has specifically permitted same beyond the aforementioned times and dates. A denial of such an exception permit may be appealed to the City Council at the next regularly scheduled meeting of the City Council following the applicant's denial.
