ORDINANCE NO. 188

AN ORDINANCE AUTHORIZING CONTRACT PURCHASE OF LEAD FREE GASOLINE AND DIESEL FUEL AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to specifications prepared by the City of Wilsonville's Public Works Director, Larry Blanchard, the City of Wilsonville duly called for bids for a supply of lead free gasoline and diesel fuel; and

WHEREAS, the City of Wilsonville received four (4) bids and the results of the bidding reported to the Mayor and Wilsonville City Council by Memorandum of July 1, 1981, of Public Works Director, Larry Blanchard, as follows:

1. Star Oil: 4,000 gallons lead free gasoline @ 1.225/gallon = \$4,900
4,000 gallons diesel @ 1.073/gallon = \$4,292
\$9,192
 - A. Will provide a delivery contract and guarantee petroleum delivery.
 - B. Will guarantee price on contract for up to 18 months.
2. Collins Oil Co.: 4,000 gallons lead free gasoline @ 1.2365/gallon = \$4,946
4,000 gallons diesel @ 1.086/gallon = \$4,344
\$9,290
 - A. Guarantees supply of product if purchased under contract and in constant volumes.
 - B. If payment is made in full 10 days from the date of delivery 1 1/2¢ per gallon can be deducted.
.015 x 8,000 = \$120.00


Section 3. Payment by the City of Wilsonville of the purchase contract authorized in the above are to be made according to the schedule of payments as outlined in the purchase contract.

Section 4. In order that these supplies come on line to provide efficient, timely and cost effective services to the citizens of Wilsonville, an emergency is hereby declared to exist, and this Ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.


Submitted to the Council and read the first time at a regular meeting thereof on the 20th day of July, 1981, and scheduled for second reading at a regular meeting of the Council on the 3rd day of August, 1981, commencing at the hour of 7:30 o'clock p.m., at the Wilsonville City Hall.

The July 1, 1981, Memorandum went on to recommend that the low bid of \$9,192 from Star Oil be accepted.

WHEREAS, the City Council/Contract Review Board has considered the bids, the specifications regarding said supplies, and the report and recommendation of its Public Works Director and determined that the low bid for the lead free gasoline and diesel fuel is that of Star Oil of \$9,192.

THE CITY OF WILSONVILLE ORDAINS, as follows:

Section 1. The bid of Star Oil for lead free gasoline and diesel fuel in the amount of \$9,192 is hereby accepted in accordance with the specifications as prepared by the Public Works Director.

Section 2. The Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville on its behalf a contract with Star Oil for the purchase of lead free gasoline and diesel fuel, according to the specifications as may be approved by the City Council and which said specifications are now on file in the office of the City Recorder.
