## A RESOLUTION OF THE URBAN RENEWAL AGENCY OF THE CITY OF WILSONVILLE AMENDING RESOLUTION NO. 32, PERTAINING TO THE WILSONVILLE ROAD PHASE 1 PROJECT, ADDING EXHIBITS 20 & 21.

WHEREAS, Resolution No. 32, adopted by the Urban Renewal Agency Board October 7, 1996, is entitled "A Resolution of the Urban Renewal Agency of the City of Wilsonville making findings and determinations authorizing and identifying minor changes to the Year 200 Urban Renewal Plan and authorizing the acquisition of property and property interests to carry out the Urban Renewal Plan and to carry out a portion of Urban Renewal Plan Project 601.A.7, Wilsonville Road Phase 1"; and

WHEREAS, the Wilsonville City Council held a public hearing on December 16, 1996, to receive additional public input regarding landscaping and pedestrian issues and options that were refined through public workshops held on September 23, 1996, October 17, 1996 and October 28, 1996; and

WHEREAS, on December 16, 1996, Wilsonville City Council directed staff to proceed with construction documents based on December 16, 1996, landscape architectural plans; and

WHEREAS, after further analysis of intersection geometry and pedestrian improvements it was deemed necessary to acquire additional right-of-way from two tax lots and these improvements have been planned and located in a manner most compatible with the greatest public good and the least private injury; and

WHEREAS, staff recommends amending Resolution No. 32 by adding exhibits 20 & 21.


